WHEREAS: the Mayor and City Council of the City of Lilburn recognize the importance of a vibrant, connected, and economically strong downtown as the heart of the community; and

WHEREAS: the city has undertaken a comprehensive planning process to develop a Downtown Master Concept Plan that reflects the community's vision for land use, transportation, public spaces, economic development, and quality of life within the downtown area; and

WHEREAS: this planning process has included analysis of existing conditions, identification of opportunities and challenges, and the development of a long-term framework to guide public and private investment in downtown Lilburn; and

WHEREAS: the city has provided opportunities for public input through meetings, stakeholder discussions, and other outreach efforts to ensure that the Downtown Master Concept Plan reflects the priorities and aspirations of residents, businesses, and community partners; and

WHEREAS: the Downtown Master Concept Plan is intended to serve as a guiding document for future policy decisions, capital projects, zoning and development regulations, and redevelopment efforts within the downtown area; and

WHEREAS: the Mayor and City Council find that adoption of the Downtown Master Concept Plan is in the best interest of the health, safety, and welfare, and will further the long-term economic, social, and physical well-being of the City of Lilburn and its citizens.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Lilburn, Georgia, sitting in regular session on March 9, 2026, as follows:

1. The document entitled "City of Lilburn Downtown Master Concept Plan" attached as Exhibit A together with all maps, exhibits, and appendices thereto is hereby adopted as the official downtown master concept plan for the City of Lilburn.

2. City staff are directed to use the Downtown Master Concept Plan as a guiding document in reviewing development proposals, preparing capital improvement programs, pursuing grants and partnerships, and recommending updates to the City's comprehensive plan, zoning ordinance, development regulations, and related policies affecting downtown.
3. Nothing in this Resolution shall be construed to supersede any existing ordinance or regulation; however, the Downtown Master Concept Plan shall be used to inform and guide future amendments to such ordinances and regulations as may be deemed appropriate by the Mayor and City Council.
4. City staff are further authorized and directed to share and promote the Downtown Master Concept Plan with community stakeholders, partner agencies, and the general public, and to periodically report to the Mayor and City Council on progress toward implementation.

BE IT FURTHER RESOLVED that this Resolution shall become effective immediately upon its adoption.
