A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LILBURN, GEORGIA, AUTHORIZING THE 2025 GENERAL MUNICIPAL ELECTION SCHEDULE, ESTABLISHING QUALIFYING FEES, AND APPOINTING THE MUNICIPAL ELECTION SUPERINTENDENT.

WHEREAS: Chapter 2 of Title 21 of Georgia Code, the "Georgia Election Code," provides state law governing candidate qualifications, election dates, municipal election superintendent duties, poll officer qualifications, voter registration, absentee voting regulations, and other municipal election requirements; and

WHEREAS: The Mayor and City Council shall comply with all state and local municipal general election requirements.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Lilburn, Georgia, sitting in regular session on July 14, 2025, that the 2025 General Municipal Election Schedule is provided in Exhibit A.
